## Deer Management Update

No hunting is allowed on Sundays, six weeks during fawning season and two weeks after Christmas.

Action Items for the Program:

- 1. Recruit
- 2. Open up with neighboring townships like Plumstead Township, Buckingham Township or Upper Makefield Township

Chair Moule will be going to Buckingham Township to discuss the program in hopes they will want to get involved with the deer management program.

Handout titled, "Solebury Township Deer Overpopulation Overview" was distributed and discussed by the committee.

Handout titled, "Deer & Deer Management in Developed Areas" was distributed and discussed by the committee.

Handout with property owners, property owner's addresses and acreage was distributed and discussed by the committee. Property owners may be approached to see if they would be interested in the deer management program to allow hunting on their property. Each committee member is to review the list

and add their name if they feel comfortable enough to approach a homeowner to discuss the program.

# Aquetong Spring Park Committee Update

Ms. Tai spoke about the use of herbicides at the Aquetong Spring Park in controlling the invasive plants. Princeton Hydro will be looking for an alternative way for spraying other than Round-Up. The Board of Supervisors would like the EAC to make recommendations in controlling the types of invasive plants. It was also noted that mechanical removal with volunteer labor may be a possibility or a mix of approaches using herbicides on the most aggressive/most difficult plants to remove and mechanical removal for others. Princeton Hydro recommends that a first application be done in May.

NRCS Pest Management – Invasive Plant Control

Princeton Hydro recommendations and cost proposal for the management of invasive plants within the Aquetong Park during the 2017 season. Princeton Hydro will focus on the Japanese Honeysuckle, common weed, Multiflora Rose, Red Canary Grass and Mugwort.

It was noted that the Aquetong Spring Park Committee will meet April 27, 2017 at 7:00 p.m. and representatives from Princeton Hydro will be in attendance.

Mr. Benner volunteered to draft a report on using the black plastic method for the removal of invasive plants.

## Wild Area Stewardship

It was noted that the goal for wild area stewardship should be a yearly walking inspection tour done by the State Forrester and then provide a one page report to the township in order to report anything that may need to be addressed. This would be helpful in providing information to the public to educate people concerning woodlands and wooded acres within the township and ongoing issues.

## Roadside Spraying - Discussion Continues

#### Green Points for Building

It was noted that Mr. Francis will need to meet with the Township Manager, Dennis Carney, for an update.

## Recycling at Parks

Ms. Alderfer and Ms. Lesh met with Dudley Rice, Park and Recreation Director, to discuss promoting recycling in the township parks, schools, and especially for all the sports events that take place throughout the year. Recycle cans have been setup in Laurel Park and it was felt more signage would be needed to promote the program. Ms. Alderfer will be monitoring the issue and will approach the school district on promoting the program within the schools. She will be meeting with Waste Management to discuss a recycle audit with the school district.

## Earth Day Cleanup

The Aquetong Watershed will hold their cleanup on Earth Day, April 22, 2017 with rain date to be Sunday, April 23, 2017.

Carversville did their annual support cleanup on April 9, 2017.

The Paunacussing Watershed Association and Tinsman Brothers Lumber held their cleanup on April 9, 2017.
