VI REPORTS ON FACILITIES

Board members reviewed the facilities report.

Additional work was required on the new multi-purpose field at Laurel Park and was recently completed which included the following per contract with Integrated Turf Management:

- Core aerate field in 6 to 8 directions
- Top-dress with 25 cy organic soil material
- Top-dress with 25-30 tons of coarse sand
- Drag and mix material into the existing soil
- Drill seed and verti-cut in multiple directions using athletic field mix
- Irrigate as needed
