Following a discussion and review of the plan by the P&R members, and an explanation of the recreation requirements in the SALDO, there was agreement that the Fee in Lieu of Land would be appropriate for the Kenton Minor Subdivision and the following motion was made and voted:

**<u>MOTION 18-11</u>**: On a motion by Andy Kelly, second by Kevin Campbell, the Board of Parks and Recreation, by a unanimous vote, recommends to the Supervisors that a fee in lieu of land be approved for the Kenton Minor Subdivision TMP #41-13-4 (Twp. Plan No. 18-603), in the amount of \$4,000 per dwelling unit / total of \$8,000 in accordance with Section 22.523 of the Subdivision and Land Development Ordinance and the fee schedule approved on January 2, 2018; and further, that the payment of the \$4,000 for the existing dwelling unit be made as a condition for Final Plan Approval by the Township, and payment of the \$4,000 for the proposed new dwelling be made upon application for the building permit.

He has served as Chair and Vice-Chair, works all the P&R events, and serves as a member of the Winter Festival Committee in charge of the most successful event, the Chili Cook-Off.

Member Kevin Campbell's term also expires at the end of the year and has requested that he be re-appointed by the Supervisors to another 5-year term.

The Music Mountain Theatre holiday concert, sponsored by Solebury P&R, is this weekend on both Friday and Saturday nights, with a portion of the ticket sales going to support Fisherman's Mark, a community support organization and local food pantry that promotes stability, health, and education that positively change the lives of our neighbors and families.
