PA Farm Link

Discussion was continued from previous meeting. Kevin Morrissey suggested having educational meetings for landowners to become more involved and knowledgeable on farming in Solebury. Mr. Morrissey stated the Township would be willing to support if the committee demonstrates enough interest. Ways to get landowners involved included extension outreach, surveys to landowners and developing list of properties with 10+ acres; additionally, holding workshops to connect landowners with farmers and vice versa.

Agricultural Use Ordinance

There were concerns with the proposed Ordinance in regards to setbacks; storage of farm equipment and coverage of acreage with high tunnels. There is a concern with the

loss of acreage if there is a 150ft lot line setback mandated. Josh Perlsweig will reach out to the Solicitor's office and Planning Commission regarding concerns.

Temporary Lodging Ordinance

The proposed Lodging Ordinance does not address the concerns of Farmers looking to house employees; the Farm Committee will look at addressing these issues in the future. Main concerns are kitchens and bathrooms and county approval; Mr. Perslweig will reach out in regards to alternative toilets; compost septics.
