He asked the Board to authorize to Township to move from the existing Memorial Program to the Memorial Tree Program, which would be implemented for all Township Parks. Mr. Baum Baicker questioned if a plan would be developed, including types of trees and fees. Mr. Rice advised that once the program details are developed the information would be presented to the Board.

Mr. Francis suggested the program name be Celebration Tree Program, so it could be used for all life events not just memorials. Mr. Francis expressed interest in the development of a program containing set tree planting locations in each park and the type of trees. Mr. McEwan suggested having tree identification, as well as, dedication message to make the program educational. Ms. Howe suggested a tier program containing different price ranges.
