# Solebury Township Hall/Virtual - Hybrid Meeting MEETING MINUTES

Attendance: Mark Baum Baicker, Chair, Hanna Howe, Vice-Chair, John S. Francis, Kevin Morrissey, Robert McEwan, Christopher Garges, Township Manager, Michele Blood, Assistant Township Manager, and Catherine Cataldi, Secretary. Mark L. Freed, Township Solicitor was in attendance.

The recording device was turned on.

- I. The meeting was called to order followed by the Pledge of Allegiance.
- II. Approval of Bills Payable March 16, 2023

Res. 2023-46 – Upon a motion by Mr. McEwan, seconded by Mr. Morrissey, the list of Bills Payable dated March 16, 2023 was unanimously approved as prepared and posted.

III. Approval of Meeting Minutes – March 9, 2023 Meeting

Res. 2023-47 – Upon a motion by Mr. Francis, seconded by Mr. McEwan, the Minutes of the March 9, 2023 Meeting were unanimously approved as prepared and posted.

# **IV.** Supervisor Comment

Mr. Baum Baicker expressed gratitude from the Board to Senator Steve Santarsiero and Representative Tim Brennan for delivering Solebury Township with two (2) grants. The one grant is for four hundred and sixty-four thousand seven hundred and fifty-eight dollars \$464,758 to be used for the Solebury Gateway Trail Project. The second grant is for a little under one hundred and ninety-four thousand dollars (\$194,000) to be used for the design work to improve pedestrian and road safety on Route 202 at Lower Mountain Road.

Mr. Baum Baicker honored Ron Ewer with words of remembrance written by Jim Searing. The Board expressed their condolences.

# V. New Business

# Authorization to Appoint Consultant for Energy Audit of Municipal Complex

In response to the Board's request following the BSEG's HVAC system presentation on August 16, 2022 the administration solicited three proposals for an energy audit for the municipal building. Christopher Garges, Township Manager, Kate Robeson-Grubb, Sustainability Specialist, Supervisor McEwan, Supervisor Francis and Shannon Pendleton, EAC Member met with the consultants to discuss the proposals and qualifications.

The team unanimously recommended that the Board appoint EAM Associates as Township Consultant to complete the energy audit for the Municipal complex based on their combination of experience and fee.

The Board and Mr. Garges expressed gratitude to Ms. Pendleton for he time, guidance and expertise throughout the process.

Res. 2023-48 – Upon a motion by Mr. Francis, seconded by Mr. McEwan, it was unanimously agreed EAM Associates as Township Consultant to complete the energy audit for the Municipal Complex.

# Bid Award – Highway Materials

Bids for black top and miscellaneous stone and aggregate have been received by the Bucks County Consortium and reviewed by Solebury Township Administration.

Res. 2023-49 – Upon a motion by Mr. Baum Baicker, seconded by Mr. Francis, it was unanimously agreed to award the highway materials bid as follows:

- ➤ No. 2B ¾" Stone, No. 2A Stone Mix and R-4 stone to: Plumstead Materials
- ➤ Rip-Rap Mixed Stone, Super Pave 9.5 mm Wearing, and Super Pave 19.0 mm Binder to: Eureka Stone Quarry, Inc.
- Super Pave 12.5 mm Wearing to: Walter R. Earle-Morrisville LLC

# Resolution for the Department of Conservation and Natural Resources' Community Conservation Partnership Program Grant

The Department of Conservation and Natural Resources' Community Conservation Partnership Program Grant to be used for the Solebury Township Parks, Recreation, Open Space Trails & Greenway Plan includes a resolution that required adoption by the Board of Supervisors.

Res. 2023-50 – Upon a motion by Mr. Morrissey, seconded by Ms. Howe, it was unanimously agreed to adopt the resolution granting authority to Christopher Garges for execution of all documents associated with the Community Conservation Partnership Program Grant for the Solebury Township Parks, Recreation, Open Space, Trails & Greenway Plan.

#### Environmental Advisory Council - Sustainability Subcommittee Announcement

The Board announced the formation of the Environmental Advisory Council - Sustainability Subcommittee. The goal of the subcommittee is to carry out the goals and objectives of the Energy Transition Plan and highlight public education initiatives. The Sustainability Subcommittee parameters include the following:

- 1. No more than three members of the EAC (less than a quorum)
- 2. Will include Associate members of the EAC (up to five)
- 3. Will make recommendations to the EAC which will then make recommendations to the Board of Supervisors.
- 4. Will be supported by staff member Kate Robeson-Grubb
- 5. Will hold hybrid public meetings which will be recorded
- 6. The Township will create a page on the Township's website for the public outreach component of the EAC and its subcommittee.

# Environmental Advisory Council – Logo Approval

The Environmental Advisory Council (EAC) requested approval of a logo design to be used, when applicable, to bring public attention to the work of the EAC.

Discussion ensued on the font and colors of the logo presented.

Andrew Speedy, resident, commented on the presented logo. Mr. Speedy expressed support for the logo to be modified to look similar to the Township and Parks & Recreation Board logos.

The Board is to hold further discussion on this topic at the April 4, 2023 Board of Supervisors meeting.

# **Bucks County Municipal Consortium Resolution**

The Board reviewed the Bucks County Municipal Consortium resolution. Discussion ensued between the Board. It was determined that Solebury Township would follow the progress of the consortium to potentially join at a later date.

# VI. Public Comment

Brian Mitchell, resident, questioned the noise restrictions within the Township. Mr. Mitchell expressed distress regarding nonstop noise made by landscapers at a neighboring property. Mr. Mitchell tried discussing with the landscapers with no resolution.
