Kaitlin Farbotnik found a platform "Eat from Farms" which is relatively inexpensive. This platform hosts several farmers market. The concept is that customers shop online for various products then physically pick up the items they ordered. A buyer can purchase from multiple markets at one time but pick up the items at the same time.

Extension service used to do booklets that provided information to local farms, etc. This approach could be a possibility for the committee to produce booklets with information about Solebury Farms.

The Committee will explore a few outlets including a survey to residents gauging interest in a market and reaching out to the Township about using Township property (Public Works building).
